- Pursuant to the Law on Prices No. 16/2023/QH15 dated June 19, 2023 of the National Assembly of the Socialist Republic of Vietnam;

- Pursuant to Decisions No. 809/QĐ-BGTVT, 810/QĐ-BGTVT, 811/QĐ-BGTVT, simultaneously dated July 1, 2024 of the Ministry of Transport;
- Pursuant to the Charter of organization and operation of Hateco Hai Phong International Container Terminal Company Limited.
- Pursuant to the market situation of Hai Phong seaports

**DECISION**

**Article 1:** Issued together with this decision are the **General Regulations (Appendix 01), the Domestic Service Tariff (Appendix 02), and the International Service Tariff (Appendix 03)** applicable to services provided by Hateco Hai Phong International Container Terminal Company Limited (HHIT)

**Article 2:** Rates specified in the Tariffs **are exclusive of** value added tax (VAT). The value added tax is subject to applicable Government regulations.

**Article 3:** Directors and heads of relevant departments are required to implement the decision accordingly.

**Article 4:** This Decision takes effect from **September 1, 2025**, and supersedes any previous documents that conflict with it.

## APPENDIX 01: GENERAL REGULATIONS

*(Issued together with decision No. /2025/QĐ-HHIT dated August 25, 2025)*

### 1. Applicability of domestic service tariffs:

- Organizations and individuals transporting cargos between Vietnamese seaports by waterway transportation modes, regardless of Vietnamese or foreign vessels.
- Containerized imports/exports and transshipment cargos, as regulated in Vietnamese seaport service tariffs, shall be paid by the cargo owners.
- Cargos transported domestically shall be paid by the domestic ship operator

### 2. Applicability of international service tariffs:

- Waterway vehicles, regardless of whether Vietnamese or foreign vessels operate, transport containerized goods from HHIT to other countries and from other countries to HHIT, international transit and transshipment cargos (collectively referred to as international transport), that actually enter, leave, or berth in the water premise of HHIT.
- The service rates for imported, exported, transited, or transshipped goods and containers shall be paid by the carriers or the authorized party for the transportation.

### 3. Applicability of combined international and domestic transport:

- In case of returning domestic goods or not returning goods and then receiving exported goods at the terminal:
  - Upon arrival, the rates for domestic vessels (domestic tariff) will be applied.
  - Upon departure, the rates for international vessels (international tariff) will be applied.
- In case of returning imported goods and then receiving goods for domestic transport or not receiving goods:
  - Upon arrival, the rates for international vessels (international tariff) will be applied.
  - Upon departure, the rates for domestic vessels (domestic tariff) will be applied.
- In case of transporting imports, exports and/or empties where the vehicles enter and exit the terminal (but not receive returned goods) due to special reasons, the rates for domestic vessels (domestic tariff) will be applied.

### 4. Interpretations:

- **Warehouse, container yard (CY):** Warehouses and yards located on the land of HHIT and managed by HHIT.
- **Exported goods (containers):** Goods with the (original) place of consignment in Vietnam and the (final) place of receipt abroad.
- **Imported goods (containers):** Goods with the (original) place of consignment abroad and the (final) place of receipt in Vietnam.
- **Transit Goods (containers):** Goods with the (original) place of consignment and the (final) place of receipt outside the territory of Vietnam, either being transported directly or handled at Vietnamese seaports, or stored at warehouses and yards for further transportation to another terminal.
- **Transshipment goods (containers):** Goods discharged from vessels and moved into the transshipment area for a certain period of time, then loaded onto another vessel for further transportation to another terminal.



- **Vessel:** Seagoing vessels, river vessels and other types of ships, boats and vehicles (whether motorized or non-motorized) operating in the sea and water areas connected to Vietnamese waters.
- **Tugboat:** Equipment designed, inspected, and registered to operate as a towing service and assist vessels entering or leaving the terminal. 01 hour of service equals 01 tugboat. The minimum Tugboat Power is subject to the regulations of the Hai Phong Port Authority.
- **Carrier:** The one who uses a vessel owned either by himself or by another person to transport goods and passengers.
- **Authorized party:** An organization or individual authorized by the customer or carrier to carry out the transportation, loading, discharging, delivery and preservation of goods.
- **Dangerous goods (DG):** Goods that are hazardous and dangerous to people, vehicles, equipment at the Terminal, and the environment, according to Vietnamese law and international treaties.
- **Oversize container:** A container that has one of the following features: a height of over 2.9m or a width of over 2.5m.
- **Overweight container:** A container with a total weight of more than 40 tons.

#### **Abbreviations:**

- S/O: Ship Operator
- C/O: Container Operator
- LOA: Length of Overall
- CY: Container Yard
- CFS: Container Freight Station
- F/A: Forwarding Agent
- FR: Flat Rack
- OT: Open Top

### **5. Currency of terminal service rates and tariffs**

The currency for payment collection and service rate calculation is US Dollars (USD) or Vietnamese Dong (VND). The payment of service rates and tariffs in foreign currency is subject to applicable Vietnamese regulations on foreign currency management. Currency conversion from US Dollars to Vietnamese Dong is based on the exchange rate listed by the bank processing the transaction at the time of payment.

### **6. Specific regulations on the units of terminal service rates and tariffs**

Service rates and tariffs are calculated based on gross tonnage (GT); the power unit of the main engine is measured in horsepower (HP) or kilowatts (KW) of the vessel; time is measured in hours and days; cargo volume is calculated in tons (T) or cubic meters (M<sup>3</sup>); containers and vehicles are calculated per unit.

- **Tonnage unit:**
  - For container vessels: tonnage for service rate calculation is the maximum gross tonnage (GT) recorded in the certificate issued by the registry agency.
  - For Tugboats: 1HP is equivalent to 0.5 GT
  - For barges: 1 ton of registered tonnage is equivalent to 1 GT

**Unit of engine power:** horsepower (HP) or Kilowatt (KW). Fractions less than 1 HP (or KW) are rounded up to 1 HP (or KW).

**Unit of time:** days and hours (Not applicable to yard storage and reefer services).

- Day: One day is equal to 24 hours; fractions less than 12 hours are counted as  $\frac{1}{2}$  day, and from over 12 hours to 24 hours is counted as 01 day.
- Hour: One hour is equal to 60 minutes; fractions less than 30 minutes are counted as  $\frac{1}{2}$  hour, and from over 30 minutes to 60 minutes is counted as 01 hour.
